JOLLY GEOFFREY'STM GOLDEN REWARDS SCAVENGER HUNT CANADIAN ADVENTURE OFFICIAL CONTEST RULES & REGULATIONS

The "Jolly Geoffrey'sTM Golden Rewards Scavenger Hunt Canadian Adventure" Contest (the "<u>Contest</u>"), is sponsored by Toys "R" Us (Canada) Ltd. (the "<u>Sponsor</u>"). The Contest will be conducted in Canada only.

By entering the Contest, contestants (the "Contestants" and each a "Contestant") agree to abide by these Official Contest Rules & Regulations (the "Contest Rules") and the decisions of the Sponsor with respect to all aspects of the Contest including the interpretation of these Contest Rules, which are final and legally binding on the Contestant. Please note that all references to time in these Contest Rules refer the local time in the jurisdiction where the Prize is located.

1. **HOW TO ENTER:** No purchase is necessary to enter or participate in the Contest. On Saturdays and Sundays between October 5, 2024, and October 27, 2024 (the "Contest Period", Sponsor's mascot, Geoffrey, will hide in one of eight (8) select city locations across Canada. The prize awarded to the first Contestant to locate Geoffrey is a \$500 gift card redeemable at Sponsor locations across Canada (the "Prize"), as described below. For further specificity, the Contest will run on each of the following days between the hours of 10 A.M. – 4 P.M. (each a "Game Day"): i) Saturday October 5, 2024, ii) Sunday, October 6, 2024, iii) Saturday, October 12, 2024, iv) Sunday, October 13, 2024 v) Saturday, October 19, 2024, vi) Sunday, October 20, 2024, vii) Saturday October 26, 2024, and viii) Sunday October 27, 2024.

On each Game Day one Prize will be awarded. Prior to each Game Day a clue or clues will be released by the Sponsor as to where Geoffrey will be hiding in Canada via one or more of: (i) posts on the Sponsor's TikTok page; (ii) posts on the Sponsor's Instagram page; and (iii) on the Sponsor's website (https://www.toysrus.ca/jollygeoffrey). The first Contestant to locate Geoffrey correctly during a Game Day and share the password "Golden Gift Card" will win the Prize for that Game Day. No prize will be awarded for a given Game Day if Geoffrey is not found on that Game Day.

- iii. The Sponsor's determination of the first eligible Contestant to locate Geoffrey during a Contest Period at each designated landmark will be final.
- iv. All Contest materials (including images or representations of Geoffrey) are the property of the Sponsor and Contestants are not authorized to use his image or trademark.
- v. If Geoffrey is not found by the end of a Game Day the Sponsor reserves the right to not award any Prize on such day.
- vi. If there is a tie or a dispute regarding which Contestant first located Geoffrey, Sponsor staff are entitled to determine a winner on whatever grounds they deem

- appropriate, including by way of a coin toss. A Contestant who wins by coin toss may be required to answer a skill-testing question to claim their Prize.
- vii. By entering the Contest, all Contestants waive and release any and all claims which they have or may in the future have against Sponsor, its affiliates, and their respective directors, officers, employees, agents, representatives, shareholders, suppliers, promoters, successors, and assigns (collectively, "Releasees") arising out of or attributable to Contestant's participation in the Contest or the acceptance or use of the Prize, due to any cause whatsoever, including without limitation the negligence of Sponsor or any other Releasee, breach of contract, or breach of any statutory or other duty of care owing under occupiers liability legislation or otherwise.

 - ix. No responsibility is assumed by the Sponsor for any inability of any person to successfully enter the Contest for any reason, or any advantages or disadvantages in relation to other Contestants, including transportation costs, accessibility or mobility issues, any problems or technical malfunction of any Internet network, social media platform, or broadcast transmission during or related to the Contest.
 - x. The Sponsor reserves the right at its sole discretion to disqualify any Contestant from the Contest in the event it is determined that they have failed to comply with the Contest Rules or any other pertinent terms or conditions referenced in the Contest Rules.
 - xi. In the event of an attempt or violation of criminal or civil laws by a Contestant or any other person, the Sponsor reserves the right to seek remedies and damages from any such person to the fullest extent permitted by law.
- 7. **CHANGE OR TERMINATION:** The Sponsor reserves the right to terminate, suspend, or modify the Contest without liability, and without prior notice or publication. In the event of early termination of the Contest, a notice will be posted online.
- 8. **PERSONAL INFORMATION:** The Sponsor respects your right to privacy. By entering this Contest, each Contestant consents to the Sponsor collecting, storing, and using the personal information submitted with their entry in accordance with its privacy policy. The Sponsor shall deal with such personal information in keeping with the Sponsor's Privacy Policy, which can be found at <u>ToysRUs Privacy Policy Toys R Us Canada</u>.

- 9. **GOVERNING LAW:** all matters relating to the Contest including the Contest Rules are governed by the laws of Ontario and the federal laws of Canada applicable therein. Any related dispute shall be resolved in the courts in Ontario.
